Class Nursery to Class II

The evaluation for Classes Nursery to II is continuous and comprehensive assessment of the growth and development of the child in various areas of learning set in the curriculum. Its aim is to measure the level attained by the child in different areas continuously, throughout the year. The curriculum emphasizes on the overall growth and development of the child. Our curriculum is designed to encourage learning outcomes that focus on nurturing children to develop holistically, morally aesthetically and globally, including skills acquisition and academic excellence.

The academic session is divided into 3 terms.

Term I	April to August
Term II	September to December
Term III	January to March

There will be no formal exam for Classes Nursery to II. Child's progress is measured by the teachers on going observation over the whole year and not on a single test. In each term, assessment progress report is based on the continuous evaluation based on class activities worksheets, assignments on day to day basis. To enhance vocabulary and confidence among children, mass activities are held throughout the year.

Assessment is the lens for diagnosing learning difficulties and inadequacies of learners. We use a trans-disciplinary approach to utilize all possible resources providing maximum exposure to students for developing numerous competencies by exploring the concepts from various perspectives and multiple disciplines.
